I, the undersigned, agree that the nature of this activity is inherently dangerous and may result in personal injury, death or damage to personal property.

I, the undersigned, hereby release, waive, discharge and covenant not to sue the NYS Woodsmen's Field Days Inc and any of the advisors, officers, servants, agents, sponsors and employees of the above (herein after referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including death, that occurs as a result of the undersigned, participation in the above listed activity.
