Dear Contestant,

Welcome to year 10! This year's three day competition will consist of preliminary rounds starting on Friday @ 5pm. The US Title Two Man Crosscut & US Title Jack and Jill will also be held on Friday night. Saturday's competition will be run in the flight format with the top 20 competitors being automatically seeded in each event. All other competitors will qualify for positions 20-25 on Friday night. We have added a Master Standing Block and Underhand. Competitors 50 and older are eligible. If you sign up for the Masters chops, you are not eligible for Championship Standing and Underhand. Competition begins on Saturday at noon. Registration will begin Friday evening from 2-4 p.m. Axe Throw preliminaries will be held during block set-up/retrieval Saturday morning. Competition will begin at noon on Sunday.

This year we are changing our format; in the Men's events the top 10 times will move into 2 semifinals of five and then into a final on Sunday. The top five athletes from Friday's qualifying rounds will also be paid out. Axe throw this year will be a US Title event, \$1000 winner takes all. The top 8 qualifiers will then be bracketed into a single throw elimination style throw off. All competition wood will be Aspen and White Pine. All heats will be logged matched wood. Single buck sawing will be White Pine. **Only the Top 24 athletes who apply for the Trophy Race will be accepted, everyone else will be kicked into a hard hit event. On Saturday evening we will be running a 3 board jigger race. This will be 2 heats of 5. The top 10 jigger cutters will cut, everyone else will be eligible for the butcher block buy in.**

The host venue, Living Waters Camp and Conference Center is a 150 acre privately owned summer camp. There are many very affordable accommodations for our competitors and families to stay for the weekend on the grounds. They have cabins, a lodge and campsites for everyone. We encourage all competitors to stay at the camp if possible, this means you would not have to tear down and build back up in the morning before and after the show. The rooms are reserved on a first come first serve basis. If you would like to stay in the lodge you must reserve a room ahead of time. In the past there have been issues with athletes showing up and asking for rooms when the lodge was already filled to begin with. This will not be acceptable this year. If you do not want to stay at the showgrounds you will have to find accommodations at the hotels in the Bedford area. For more info on staying at the camp please contact Tammy Sines @ 814-733-4212.
